## Annexe 2 - Méthode

Globalement, l'objectif était de trouver un algorithme visant à combiner les différentes sources d'information de façon uniforme entre toutes les revues de tous domaines. Parmi ces sources figuraient des avis de spécialistes (sollicités à l'extérieur d'HEC), des classements existants et des facteurs d'impact de revues. Les cas limites faisaient ensuite l'objet d'une discussion approfondie avant d'apporter des corrections éventuelles. Toutes ces corrections ont été réalisées en fonction d'informations factuelles supplémentaires (par exemple, taux d'acceptation ou encore évolution des facteurs d'impact).
